- Investment Report Steve Johnson
  - Discussed the system of the investments with LPL and Wells Fargo. Steve mentioned that he contacts them before each quarterly meeting to get a report.
    - Chad Kvamme Wells Fargo
      - No recommended changes to current situation
      - IREIT is up 23% for the year but it is set up for income
      - Bonds Continue to meet expected yields. 4-5% annually.
      - \$3140 in a cash account that should have been transferred but he will override that and get it deposited. Will decide later if we will use that amount in grant giving this time (50%)
      - Makes nothing on the IREIT and makes a VERY small trailing fee on the other stuff.
    - Jason Jaeger LPL
      - Not much success getting in touch with him.
      - Gave similar report as last quarter.
        - Ladder-bond investments (stacked maturity dates)
      - Not making anything on the bonds.
      - Said if we have a different investment policy than when this started, we should make that known to him.
      - Wants us to look "bigger-picture" if we want.
  - Terry made it known he is involved with investments so he needs to be left out of the discussion of where to invest money.
